



About TEEB

The Economics of Ecosystems and Biodiversity (TEEB) is a global initiative focused on drawing attention to the economic benefits of biodiversity, highlighting the growing cost of biodiversity loss and ecosystem degradation and drawing together expertise from the fields of ecosystem science, economics and development policy to support the mainstreaming of biodiversity and ecosystem considerations in policy making.

Guidance Manual for TEEB Country Studies available

The Guidance Manual for TEEB Country Studies was launched by UNEP and partners on 28 May 2013 at the 7th Trondheim Conference on Biodiversity. The economics of land degradation

This issue paper (March 2013) raises awareness about the need for and role of an assessment of the economic, social and environmental costs of land degradation. It further proposes a scientific framework to conduct such an assessment, based on the costs of action versus inaction against land degradation. Preliminary findings suggest that the costs of inaction are much higher than the costs of action. [Read more.](#)

The report handed to the Minister of Water and Environmental Affairs, on 22 May, assesses South Africa's ecosystems & species, and provides a summary of the National Biodiversity Assessment.
